#### **NEW BUSINESS:**

Chad Cowan from Monroe Custom Bodies gave a presentation on his company and the plans to move their manufacturing facility to Morristown. Mr. Cowan stated that it was a family business started in Mt. Comfort, Indiana. Monroe Custom Bodies makes various types of bodies for trucks. Council Members stated they were willing to work with Monroe Custom Bodies on this venture in Morristown.

#### **Morristown Community Fall Festival:**
