## **INTERLOCAL AGREEMENT 2020**

This Amendment ("Amendment") entered into by and between Hanover Township, Shelby County, Indiana, and Morristown Town Board as follows:

- The Treasurer of the Board as defined by the Inter Local Agreement shall either be the Hanover Township Trustee or the Morristown Clerk Treasurer as decided each year by a vote of the members of the Board.
- 2. The Morristown-Hanover Township Fire and Emergency Medical Board (referred to Herein as "the Fire Board") shall deposit and pay all debts out of the separate bank account in the name of the Fire Board.
  - a. The monetary deposits by the Hanover Township Trustee and Morristown shall be by the following terms of computation:

i. Morristown - \$ 27000.00 per year.
ii. Hanover Township - \$ 27000.00 per year.

- 3. The Inter Local Agreement and all amendments shall be deemed by the State Board of Accounts to be a "Special District".
- 4. Any contracts by the Fire Board shall be made with the approval of a majority of the Board and said contracts shall be available for access by any and all members of the Board.
- 5. The Fire Board shall have an annual budget which will be approved by the Board by the majority of the members of the Fire Board. Said budget shall be open and be accessed by all members of the public upon written request.
- 6. The Fire Board shall be audited as a separate entity by the State Board of Accounts. This amended Inter Local Agreement shall become effective upon the passage of the majority of the Fire Board during its meetings.

Any terms of the Inter Local Agreement dated August 4, 2005 which are not in conflict herewith, shall remain in full force and effect.

This Amended Agreement shall not take effect until the Township and the Town adopts Resolutions approving the same at a regular meeting of each entity.









