**MORRISON STREET WATER FILTRATION PROJECT:**

Deputy Clerk-Treasurer Roberts presented a request from Graves Construction for a time extension of 30 days. Graves stated that "We are not requesting any additional cost with this change order just and extension of time." Council Member David Benefiel made a motion to approve the request. Deputy Clerk-Treasurer went over how he arrived at the salary ordinance and reminded the Council Members that changes could be made after January 1 to all employees except the elected officials. Council Members were also made aware of in this Salary Ordinance that the Clerk-Treasurer and Deputy Clerk-Treasurer would be considered full time and eligible for all benefits like other employees of the Town of Morristown.

Council Member David Benefiel made a motion to adopt Ordinance 2019-08 as presented. Council Member William White seconded the motion. Motion approved. Vote 4/0
